The Colville Tribal Police Department shall be placed back as a stand-alone department. Detective(s) under the supervision of the Public Safety Director will be removed and placed back under the Colville Tribal Police Department. The Colville Tribal Police will report directly to the Colville Business Council under the Law & Justice Committee for law enforcement matters and the administrative process will go through the Executive Director's Office. All Tribal and Federal Funding will be remanded back to the Colville Tribal Police program including travel, training, and detective(s) position funding.
