The Confederated Tribes of the Colville Reservation Continue Work with Magellan Advisors

For immediate release December 7, 2020

NESPELEM, WASHINGTON / DENVER, COLORADO – The Confederated Tribes of the Colville Reservation in northeastern Washington have sought Magellan Advisor's continued partnership as they enter the second phase of planning for expanding broadband across the region.

Magellan's team first worked with the Tribes while developing a Broadband Action Plan for the Broadband Action Team led by the Tribes and Ferry County, Washington. Throughout the course of the study, Magellan became deeply familiar with the ongoing concerns of the communities on the Reservation about a growing digital divide that left many without affordable, reliable options for high-speed broadband. The resultant action plan recommended specific next steps including developing a broadband business plan for the Confederated Tribes of the Colville Reservation, defining a regional approach that includes the Tribes, Ferry County, Okanogan County, and stakeholders such as the public utility districts, and pursuing a variety of grant applications to fund the buildout and operations of additional broadband infrastructure.

Magellan's West Coast team will work with tribal leadership to lead these actions, including engaging stakeholders such as residents, businesses, community organizations, education, surrounding municipalities, and infrastructure owners such as Noanet and the PUDs to create a Business and Operations Plan for CCT to bring increased access to the Reservation and surrounding areas. Magellan will assist the Tribes with developing a network design and engineering analysis, which will be used to pursue state and federal grant opportunities. The development of this Plan is a critical next step to ensuring the communities on the Colville Reservation have access to high-speed connectivity that will enhance quality of place, quality of life, and economic opportunity.

Rodney Cawston, Chairman of the Colville Tribes, said, "Every community should have access to reliable, affordable, and high-speed broadband. It can be challenging to extend infrastructure to rural areas, but that challenge must be met and overcome. The Colville Tribes welcomes all willing partners in its effort to modernize vital infrastructure."
