	continuously and openly exercised since on or about the date	
	of the effectiveness of the Constitution;	
	WHEREAS, the Tribes desire to participate in the	
	Key2Purchase Program (the "Program"), which is a charge	
	card program offered by KeyBank National Association	
	("KeyBank") for charging expenses related to the	
	governmental and business activities of the Tribes; and	
	WHEREAS, the Colville Business Council has reviewed the	
	documentation necessary to maintain the Program, including	
	the: (1) Application and incorporated by reference	
	Key2Purchase Program Terms and Conditions;	
	(2)Addendum A, Addendum E and Addendum F to the	
	Key2Purchase Program Terms and Conditions; and (3) Key2Purchase Program set up documentation (collectively,	
	the "Program Documents"); and

	WHEREAS, it is the recommendation of the Management &	
	Budget Committee that the Colville Business Council	
	approve such documents as the Tribes determine necessary	
	and appropriate to maintain the program, including the execution of documentation that grants a limited waiver of	
	sovereign immunity and provides for dispute resolution	
	procedures.

	WHEREAS, it is the recommendation of the Management & Budget Committee that the Colville Business Council	
	approve and authorize the execution and delivery of the	
	Program Documents pursuant to which the Tribes will make

THEREFORE, BE IT RESOLVED, that we, the Colville Business Council, meeting in a SPECIAL SESSION this 16th day of April 2015, acting for and on behalf of the Tribes, do hereby approve the above-described recommendations of the Management & Budget Committee.

BE IT FURTHER RESOLVED, that we, the Colville Business Council, acting for and on behalf of the Tribes, hereby authorize the establishment and maintenance of the Program from KeyBank;

BE IT FURTHER RESOLVED, that we, the Colville Business Council, acting for and on behalf of the Tribes, hereby approves the form of each of the program Documents in the form presented to the Colville Business Council, and with such changes as may be approved by the Chairman of the Colville Tribe, the Vice Chairman of the Colville Tribe, the Secretary of the Colville Tribe, the Executive Director of the Colville Tribe, the Centralized Services Director of the Colville Tribe (each, an "Authorized Officer"). The Colville Business Council hereby further authorizes and directs the conversion of each Program Document into the final form thereof, together with such changes or modifications as deemed necessary or desirable by an Authorized Officer upon the approval of legal counsel. The Authorized Officers, acting alone or together, are hereby authorized and directed to execute the final form of each Program Document in the name and on behalf of the Tribes, and such signature shall be conclusive evidence of the approval of the Colville Business Council hereunder.

BE IT FURTHER RESOLVED, that we, the Colville Business Council, acting for and on behalf of the Tribes, hereby certifies that (a) this Resolution is in conformity with and does not contravene the provisions of any applicable statutes, regulations, administrative code, or other document governing or in effect for the Tribes, (b) neither the Constitution nor any agreement of any kind binding upon the Tribes prohibits the Tribes from entering into and performing its obligations under the Program Documents, which Program Documents constitute binding obligations of the Tribes, (c) the Tribes' correct Employer identification number issued by the Internal Revenue Service is _, (d) the Tribes have not been notified by the Internal Revenue Service that it is subject to backup withholding as a result of failure to report all interest or dividends, and further certifies that, in any case, the Tribes are exempt from backup withholding because it is a federally recognized Indian tribe not subject to federal income tax, and (e) this Resolution constitutes the only action required by the Constitution to be taken by the Colville Business

Council to authorize the Authorized Officers to take the actions described herein.

BE IT FURTHER RESOLVED, that we, the Colville Business Council, acting for and on behalf of the Tribes, do further specifically approve the limited waivers of sovereign immunity of the Tribes, the waiver of exhaustion of tribal remedies, and the agreement to arbitration, in each case described therein as irrevocable, in favor of the Lender contained in the Program Documents.

BE IT FURTHER RESOLVED, that we, the Colville Business Council, acting for and on behalf of the Tribes, do further find and determine that:

- (a) The Authorized Officers, and their respective successors in office from time to time, are designated the officers of the Tribes who are authorized to open and close accounts (the "Accounts") under the Program Documents, to designate a Program Administrator (as defined in the Program Documents), to designate Cardholders (as defined in the Program Documents), and to execute and deliver such documentation as may be required by KeyBank to effect the intent of this Resolution; provided however, that the Authorized Officers may not waive the Tribe's sovereign immunity, nor may they increase the Tribe's liability under Program Documents, beyond that approved in this Resolution;
- (b) KeyBank may accept the instructions of any Program Administrator, including without limitation instructions received through the electronic portal established to administer the Program, as to the administration of the Accounts, including without limitation, establishing new Accounts under the Program, adding and deleting Cardholders from the Program and revising ACLs (as defined in the Program Documents), making electronic payment from depository accounts of the Tribes for payment of the Accounts established under the Program and directing application of rebates under the Program, and that KeyBank may conclusively assume that all actions of the Program Administrator are authorized by the Tribes until receipt by KeyBank of written notice to the contrary, in accordance with the provisions of the Program Documents;
- (c) KeyBank is hereby authorized to process and pay all transactions of Cardholders, without inquiry as to the circumstances of the use of the Cards (as defined in the Program Documents), subject to the terms of the Program Documents:
- (d) All present and future rules and regulations of KeyBank

	governing the Program, including without limitation all Accounts thereunder, are hereby assented to and shall be binding upon the Tribes, in accordance with the Program Documents, but in each case subject to the Tribes' right to refuse to accept any changes thereto within thirty (30) days of receiving notice thereof pursuant to the Program Documents; and (e) The Authorized Officers may execute and deliver, or authorize other officers or employees of the Tribes in writing to execute and deliver, agreements for services related to the Program, including ACH transactions to make payments under the Program and receive rebates under the Program, among other things and bind the Tribes to all such agreements. BE IT FURTHER RESOLVED, that we, the Colville Business Council, acting for and on behalf of the Tribes, do hereby authorize and direct the Authorized Officers, acting alone or together, to execute and deliver, and to attest to the final forms of the documents referenced in this Resolution when the same have been prepared for and in the name of the Tribes, and such execution and delivery shall be deemed as conclusive evidence of the approval thereof. The Colville Business Council and any and all other officers of the Tribes are hereby authorized and directed, on behalf of the Tribes, to do any and all things and to take any and all actions, including execution and delivery of the agreements described in this Resolution, assignments, certificates, requisitions, notices, consents, instruments of conveyance, warrants, and other documents which any of such officers may deem necessary or advisable in connections with the execution and delivery of the Program Documents. BE IT FURTHER RESOLVED, that we, the Colville Business Council, acting for and on behalf of the Tribes, hereby ratifies any and all prior actions heretofore or hereafter taken by any officer or officers of the Tribes in connection with the Program and the matters described in this Resolution be, and hereby are, ratified, confirmed, approved and author
