	increased nearly six-fold from 2015-2020 and accounted for	
	nearly 73% of all opioid-involved deaths; and	
	WHEREAS Fentanyl is considered "The Next Wave	
	of Opioid Crisis." It is 50 times more potent than heroin and	
	100 times more potent then morphine. Illicit fentanyl has become a potent additive to heroin, cocaine or even	
	counterfeit prescription drugs; and	
	WHEREAS, as a result of the continued consequences	
	of the opioid crisis affecting the United States, Xavier	
	Becerra, Secretary of Health and Human Services, pursuant to	
	section 319 of the Public Health Service Act, 42 U.S.C. §	
	274d, renewed, effective January 1, 2023, that an opioid	
	public health emergency exists nationwide; and	
	WHEREAS, the severity and magnitude of this	
	epidemic make it a condition of public health importance that	
	is beyond the timely and effective response and recovery	
	capability of day-to-day Tribal operations, and emergency	
	action is required; and	
	WHEREAS, the Colville Business Council hereby	
	finds that all members of the Confederated Tribes of the	
	Colville Reservation have a stake in solving the huge and complex public health problem presented by the use of illicit	
	drugs and opioids, and	
	arabo and opioido, and	1

The Colville Business Council finds that harm reduction/health promotion, defined as equipping individuals suffering with addiction with life-improving and life-saving tools and resources, is an important means for addressing the opioid crisis.

WHEREAS, the Colville Business Council finds that collaboration across Tribal departments and programs is key to the Confederated Tribes of the Colville Reservation successfully combating the use of opioids and other illicit drugs and preserving the health and well-being of Confederated Tribes of the Colville Reservation for generations to come; and

NOW THEREFORE, BE IT RESOLVED, on this 6th day of November, 2023, under the authority granted by Constitution and Bylaws of the Confederated Tribes of the Colville Reservation, the Colville Business Council hereby declares that a condition of public health emergency exists throughout the Confederated Tribes of the Colville Reservation, and this condition is of sufficient severity and magnitude to warrant a public health emergency declaration.

BE IT RESOLVED, that the Colville Business Council hereby establishes a Drug Free Coalition whose members shall include the following:

- (1) Executive Director
- (2) Chief of Tribal Law Enforcement
- (3) Tribal Public Health Officer
- (4) Tribal Clinical Director
- (5) Tribal Prosecutor
- (6) Tribal Court Judge
- (7) Public Affairs Officer
- (8) Child Welfare Program Manager

BE IT FURTHER RESOLVED, that the Colville Business Council authorizes the Drug Free Coalition to coordinate a response, as outlined in the attached Tribal Emergency Declaration on the Opioid Epidemic Checklist.

BE IT FURTHER RESOLVED, that the Colville Business Council hereby strongly urges all community members to participate in naloxone trainings to be arranged/coordinated through the Drug Free Coalition.

BE IT FURTHER RESOLVED, that by exercising our public health powers as a sovereign tribal nation through this State of Emergency, the Confederated Tribes of the Colville Reservation will be able to continue to protect and preserve our way of life for generations to come.

BE IT FURTHER RESOLVED, that all directives, authorized actions, and provisions of the November 6, 2023 Declaration of Emergency shall remain in full force and effect until further resolution of the Colville Business Council unless earlier

	terminated or extended by the Colville Business Council.  BE IT FINALLY RESOLVED, that this Declaration of Emergency shall take effect immediately.
